### Meeting Minutes

#### **I. Welcome and Task Force Mission**

##### Ohio Attorney General Mike DeWine

- Mr. DeWine described his exposure to and experience in the mental health field both as a prosecutor and a U.S. Senator.
- Mr. DeWine explained that the task force evolved from the Ohio Supreme Court Advisory Committee on Mental Illness and the Courts (ACMIC). The group will now take a holistic approach towards addressing issues involving individuals with mental illness and the criminal justice system.
- The mission of the task force is to increase public safety, and reduce the number of individuals with mental illness in the criminal justice system.

##### Justice Evelyn Lundberg Stratton

- Justice Stratton spoke about the history of ACMIC and her involvement with Veterans issues.
- Justice Stratton reiterated the mission of the AG task force, including that the AG involvement allowed the group to address issues beyond the courtroom.

#### **II. Presentations**

##### Senior Assistant Attorney General Aaron Haslam

- Mr. Haslam presented statistics about prescription drug abuse.
- Mr. Haslam spoke of the Attorney General's efforts to combat prescription drug abuse through public education, assistance to law enforcement and partnerships with the treatment community.

##### Dr. Mark Munetz, Criminal Justice Coordinating Center of Excellence

- Dr. Munetz presented on the Sequential Intercept Model, a series of "points of interception" in the criminal justice system where individuals with mental illness could potentially be diverted to treatment.
- Dr. Munetz proposed the adoption of statewide Sequential Intercept Mapping, where community stakeholders would collaborate to identify gaps in their local system.

##### Justice Evelyn Lundberg Stratton

- Justice Stratton provided an update on the Veterans WrapAround Project.
